

Analysis of Feed back

Alumni

75% were positive about the growth and progress of the College. Designing the curriculum in tune with the employability requirements of the industry was appreciated. They felt that the Placement Cell should become more active and ensure that a reasonable member of students are placed in suitable posts. Well defined learning outcomes were to be precisely charted out in the Syllabus. Alumni associations were to be strengthened for assisting the Management in infrastructure development.

Parents

The feedback was positive. Construction of new toilets and classrooms was appreciated. A few parents had a mistaken concept that gender discrimination prevailed in the campus. Ragging free campus, student mentoring and regular academic auditing were some quality benchmarks that appealed to the parents.

Employers

40% of the respondents wanted the core skills of the students to be enhanced. More of technical learning was to be incorporated in the syllabus. The impetus given to ICT enabled learning and teaching was appreciated.

Students

As stakeholders, they were satisfied that examination results were declared on time facilitating admission to other Universities and Colleges; 80% of them were happy about the shift from a teacher centric to a student centric learning. However, they wanted the better of two CAT examination marks to be taken for continuous Assessment grading.
